2026 Plan of Work: Enhancing Safety, Efficiency, & Reliability

The Board of Directors of Tri-County Electric Cooperative has approved the cooperative's work plan for 2026, which includes a series of critical infrastructure upgrades aimed at enhancing the reliability of the electric distribution system. Each year, the cooperative evaluates its system and prioritizes a range of projects to address aging equipment, accommodate growing demand, and improve overall service for its members.

Key initiatives outlined in the 2026 plan include:

- **Pole Inspections:** Tri-County Electric conducts inspections on a regular ten-year rotation, and any poles that fail the inspection process are replaced. This year, pole inspections will take place in the following substation service areas: Veterans, Barva, Bonnie, and the southern portion of Reserve substation areas.
- **Substation Improvements:** Maintenance and upgrades will be carried out on several substations to improve their reliability, extend the life of key equipment, and boost overall system efficiency.

- **Automated Metering Infrastructure (AMI) Upgrade (Phase 1 of 3)**

Phase 1 will focus on upgrading the network infrastructure and deploying meters in select service areas, laying the groundwork for full system implementation in Phase 2. Once complete, the AMI system will strengthen communication across the entire distribution network, supporting future grid modernization efforts such as load management programs, distributed energy resources, and enhanced reliability monitoring.

The goal of these upgrades is to ensure reliable, uninterrupted service for Tri-County Electric Cooperative's members. These planned projects reflect Tri-County Electric's ongoing commitment to enhancing the safety, efficiency, and reliability of its electric grid, benefiting its members and the communities it serves.

2026 Forestry Trim Cycle: Improving Safety & Reliability

Beginning in January 2026, you may see tree-trimming crews from Asplundh working throughout our service area. These contractors are part of TCEC's 2026 Forestry Program, and when you see them out and about — know that they're working for you.

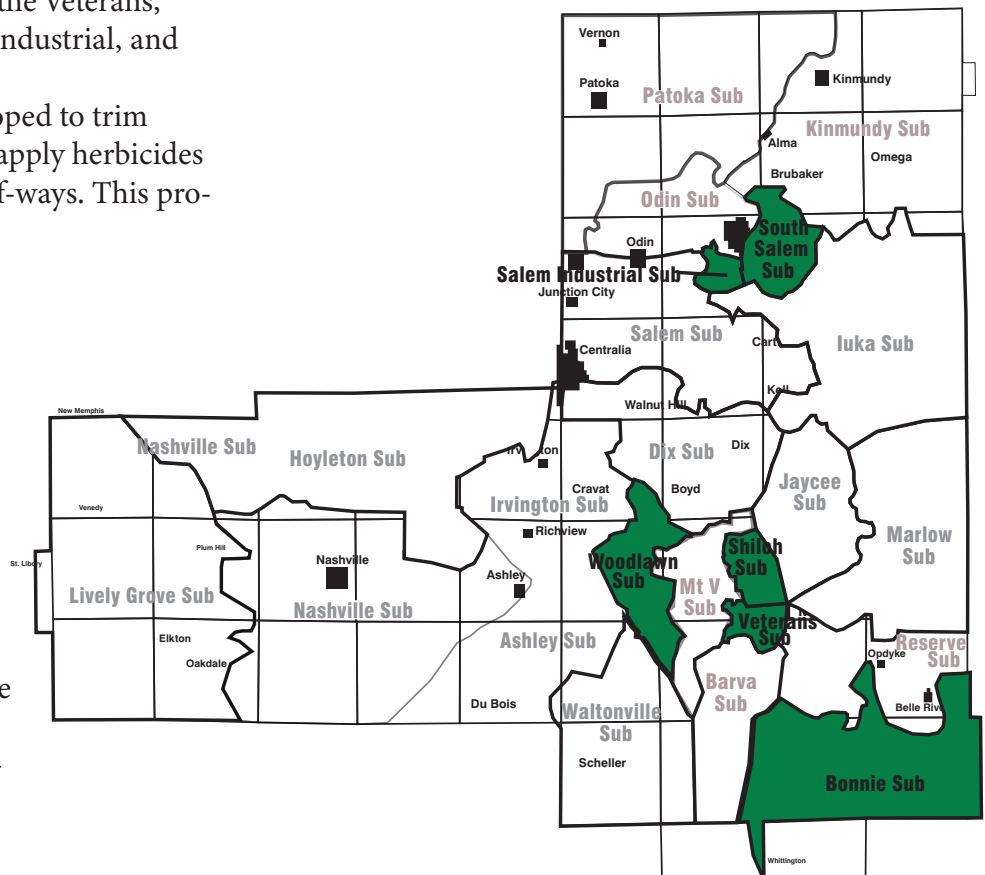
Each year, TCEC focuses on a group of substation areas as part of our four-year forestry trim cycle. For 2026, the program will include the Veterans, Woodlawn, Bonnie, Shiloh, Salem Industrial, and South Salem substations.

The Forestry Program was developed to trim and remove trees, mow brush, and apply herbicides around our power lines and right-of-ways. This proactive approach helps us: Reduce storm damage that can cause extended outages, minimize "blinks" and other service interruptions, and lower long-term maintenance costs by keeping vegetation under control.

Trees are a beautiful part of our communities, but when branches grow too close to power lines, they can create safety hazards and reliability issues. By maintaining a consistent four-year cycle, we're able to prevent problems before they start — keeping the lights on for everyone.

So if you notice crews from Asplundh in your neighborhood, know that they're helping ensure your power stays safe and reliable all year long.

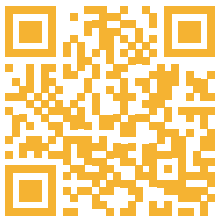
